TERMS & CONDITIONS

Please carefully read and understand the following terms and conditions governing ALLIANCE FINANCIAL SERVICES LIMITED, A MEMBER OF THE SAGICOR GROUP, JAMAICA (hereinafter "the Campaign" or "Promotion"). This is a legally binding contract which contains provisions of your rights during the campaign to protect both you and Alliance.

- The qualifying period for the promotion is **9:00am on Friday, May 6, 2022, through to and ending on Saturday, May 28, 2022, at 5:00pm.**
- The winners will be randomly selected at **10:00am on Friday, June 3, 2022, at the Alliance Financial Services Limited Head Office located at 7 Belmont Rd, Kingston** and contacted by Sagicor Group no less than two (2) business days after selection.
